Summary Annual Report

This is a summary of the annual report of the Lithko Contracting, LLC, EIN 431214734, Plan BUILDING YOUR BENEFITS HEALTH & WELFARE BENEFIT PLAN, Plan No. 505, a welfare benefit plan, for period January 01, 2024 through December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

All components of the plan other than the Health FSA component are provided through insurance contract(s).

Lithko Contracting, LLC has committed itself to pay certain Health, Temporary Disability, Other (EAP) claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with THE LINCOLN NATIONAL LIFE INSURANCE COMPANY, DELTA DENTAL OF OHIO and VISION SERVICE PLAN to pay Death Benefits (AD&D), Life Insurance, Vision, Long-term Disability, Dental, Other (EAP) incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2024 were \$2,570,514.00.

Because they are so called “experience-rated” contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending December 31, 2024, the premiums paid under such “experience-rated” contracts were \$1,110,148.00 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$905,704.00.
